Important

1. Student seeking admission to class IX & X must produce "passing certificate of third language from previous school"
2. If he/she belongs to SC/ST/OBC, a certificate should be submitted at the time of admission only.
3. **No admission is complete until Transfer Certificate in original from the last School is produced. (It should be countersigned by Education Officer in case of Non CBSE or Inter-State Transfer). If the same is not submitted within a month of admission, the admission will stand cancelled.**
4. Any person other than parent is required to submit an authority letter from the father / mother of the ward to sign any paper, to make any correspondence with the school, as their representative. A guardian other than parents will be considered only in case of loss of parents.
5. The registration form duly complete in all respects should be submitted for registration in the school office immediately. Incomplete forms are liable to be rejected without any intimation. Overwriting in forms will not be accepted.
6. The Transport facility will be provided by the school only on approved bus routes subject to availability of seats. It will be the responsibility of the parents to drop/collect the child from the specified bus stops.
7. The transport fee may vary for different routes and also as per strength of students on a particular route. Diesel charges hike may also cause a hike in the bus fee any time during the year. The parents will be intimated about the same time to time. Once the transport facility is availed the parents will be required to pay charges for eleven months. Transport facility cannot be withdrawn in the middle of the session.

DECLARATION :

1. I know that the Registration Fee is non-refundable and registration is not binding for admission. It may be given only when a suitable vacancy exists and the child's performance in the test is as per school norms. I also know that ADMISSION FEE will not be refunded after seeking admission in the Academy.
2. In case my ward is admitted in the school, I shall make my own arrangement for inoculation against typhoid, cholera & vaccination against smallpox etc to my ward from year to year and submit the detailed information to the school.
3. I confirm that I have studied the fees structure of the school of all classes from I to XII and I have made careful note of various details regarding the payment of school fees. I have made satisfactory arrangement for remittance of school fees within due dates without waiting for reminder from the School. I will pay the school fees through bank deposit/online payment or through crossed cheque, cash infavour, as per the Schedule declared by the School.
4. **I hereby certify that the date of birth & spelling of name of ward, father and mother given in this form is correct to the best of my knowledge and previous school TC. I shall not make any request for the change of the same.**
5. In case of withdrawal of my ward, I will inform the office duly submitting "T.C. Application and Form" and I will pay the fee as per school rules. In case, I wish to withdraw my ward at the end of the session i.e. 31st March I will submit the application for TC by 31st March of the same session by all means. Otherwise I will be liable to pay first term fee as per next session to be eligible to obtain the T.C. of my ward. I will inform the school duly filling TC Application form within three months from the date of absence. In case of late application of TC i.e. beyond a period, I will follow the rules & regulations of school.
6. **In case after admitting my ward I move the child to another school I will not be eligible for any refund in fee deposited.**
7. I give my consent for my ward _____ to participate in all the programmes of study, recreation, games, drama, cultural, sports, excursion and other activities organized by the school in view of holistic development of my ward. I hereby permit him/her to use transportation arranged by the school if needed and will not hold the committee/school responsible for any claims, resulting any accident etc. while coming or going to school and inside the school campus. I hereby agree to all the rules & regulation of the school as laid down by the school in Almanac, Admission Form and through SMS, Emails, Verbal and Circulars to be issued to us time to time, shall be abide by them. I hereby agree to abide by all decisions of the Principal. If my child is found indulging in any indiscipline, the Principal will have a right to punish/suspend, him/her and the Principal's decision will be final & binding on me in all matters.
8. I fully understand that the school authorities will not be liable in any case of any damage / injury / mishappening etc during the time of his/her stay in the school, while taking part in sports and in any other activity, during travelling via school transport or during participation in any tour/camp etc.
9. I understand that rendering false or misleading information or withholding correct information may disqualify the child for admission/ education in this school. I understand that no third party will be allowed to represent me on my ward in any matter.
10. Having read carefully the rules, regulations & procedures laid in the Admission Form and being desirous of having my child/ ward educated in DMA & DMI Modipuram, Meerut, I hereby agree to abide by them in all respects. I understand that the decision of the Principal shall be binding on me.
